If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.
- To the fullest extent allowed by law, I agree to **WAIVE, DISCHARGE CLAIMS, AND RELEASE FROM LIABILITY** 711, its officers, directors, employees, agents, and director(s) from any and all liability on account of, or in any way resulting from Injuries and Damages, even if caused by negligence of 711 its officers, directors, employees, agents, and director(s), in any way connected with this Project. I further agree to **HOLD HARMLESS** 711, its officers, directors, employees, agents, and director(s) from any claims, damages, injuries or losses caused by my own negligence while a participant on the Project. I understand and intend that this assumption of risk and release is binding upon my heirs, executors, administrators and assigns, and includes any minors accompanying me on the Project.
- I have read this document in its entirety and I freely and voluntarily assume all risks of such Injuries and Damages and notwithstanding such risks, I agree to participate in the Project.
